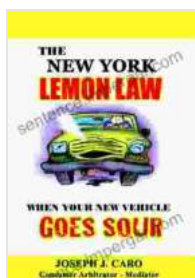

What is the New York Lemon Law?

1. **Keep a record of all problems with your vehicle.** This includes dates, times, and descriptions of the problems. You should also keep copies of all repair Free Downloads and invoices.
2. **Contact the manufacturer.** You should notify the manufacturer of the defect in writing. Be sure to include a detailed description of the problem and a copy of your repair Free Downloads.
3. **File a complaint with the New York State Attorney General's Office.** You can file a complaint online or by mail. The Attorney General's Office will investigate your complaint and may take legal action on your behalf.

What to Expect from a Lemon Law Case

If you file a Lemon Law claim, the manufacturer will have an opportunity to inspect your vehicle and attempt to repair the defect. If the manufacturer is unable to repair the defect, you may be entitled to a refund, replacement vehicle, or cash settlement.

The amount of compensation you may receive will depend on the specific circumstances of your case. However, you may be entitled to the following:

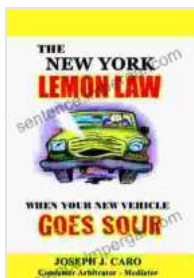
- A full refund of the Free Download price of your vehicle

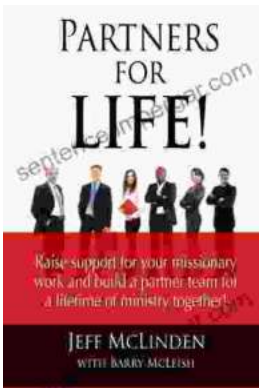
